Market Steer / Heifer Weigh-in Mandatory for 2020 Wyandot County Jr. Fair



Any Wyandot County Jr. Fair exhibitor planning to exhibit a market beef animal at the 2020 Wyandot County Fair is required to have possession of the project animal by December 14, 2019. **Exhibitors must pre-register their animal(s) for weigh-in by Wednesday, December 11, 2019 by submitting the attached information form to the <u>Wyandot County Senior Fair Office</u>. One registration form is required for EACH** market beef animal.

Exhibitors are required to weigh-in their market beef animal(s) at the **mandatory weigh-in** being held at the Wyandot County Fairgrounds **from 8:00 a.m. to 11:00 a.m. on Saturday, December 14, 2019**. Weigh-in is mandatory for all market beef animal entries.

The market beef classes for the Wyandot County are:

- 1) market steer
- 2) market heifer
- 3) dairy steer

Registration forms are available from vocational agricultural instructors in the county schools, the Senior Fair Office and at the OSU Extension Office. They will also be available in the November and December Wyandot County Clover Gram, Wyandot County web page (http://wyandot.osu.edu/program-areas/4-h-youth-development/formsnothing-forms) and at the Wyandot County Fair web site (http://www.thewyandotcountyfair.com)

The form must be completed and on file by Wednesday, December 11, 2019 to be able to weigh-in a market beef animal for the 2020 Wyandot County Jr. Fair.

If an exhibitor intends to exhibit his/her market beef animal(s) at the Ohio State Fair, the protocol includes the use of an electronic identification (EID) ear tag that has a unique 15-digit number and a DNA (hair) sample that will be submitted – <u>by the exhibitor</u> by January 15, 2020. This applies to all market beef animals that exhibitors plan to enter in the 2020 Ohio State Fair. An exhibitor must also complete a separate Ohio State Jr Fair entry form obtained online at www.ohiostatefair.com

In the event of inclement weather, the makeup date is Saturday, December 21, 2019 from 8:00 a.m. until 11:00 a.m. The weigh-in is conducted by the Jr. Fair Advisory Board.
